Elections are scheduled to be held at Brighten Academy during the November PTO voting meeting on November 26, 2018. Candidates who are selected for the voting slate are invited to speak to the PTO members in attendance shortly before voting. Board members are elected by the Brighten Academy PTO. Voters must be a registered PTO member to obtain a ballot.

Brighten believes that education is a shared responsibility among the school, home, and community. Active engagement by a qualified board filled with committed parents, educators, and other stakeholders is critical to effective school outcomes which include high student achievement, sustainability, and effective operations. Please be aware that we are a working board, meeting twice monthly. Board members are expected to be active participants in the decision-making process, for the entire three-year term, not simply in an advisory role.

- Three references (2 professional & 1 personal: name, email, phone, role/relationship)
- Brief video (2-3 minutes): introduction, reason for interest, qualifications, and other helpful information for parent voters to get to know you. (This will be placed on our website for PTO members to review prior to election night)
